

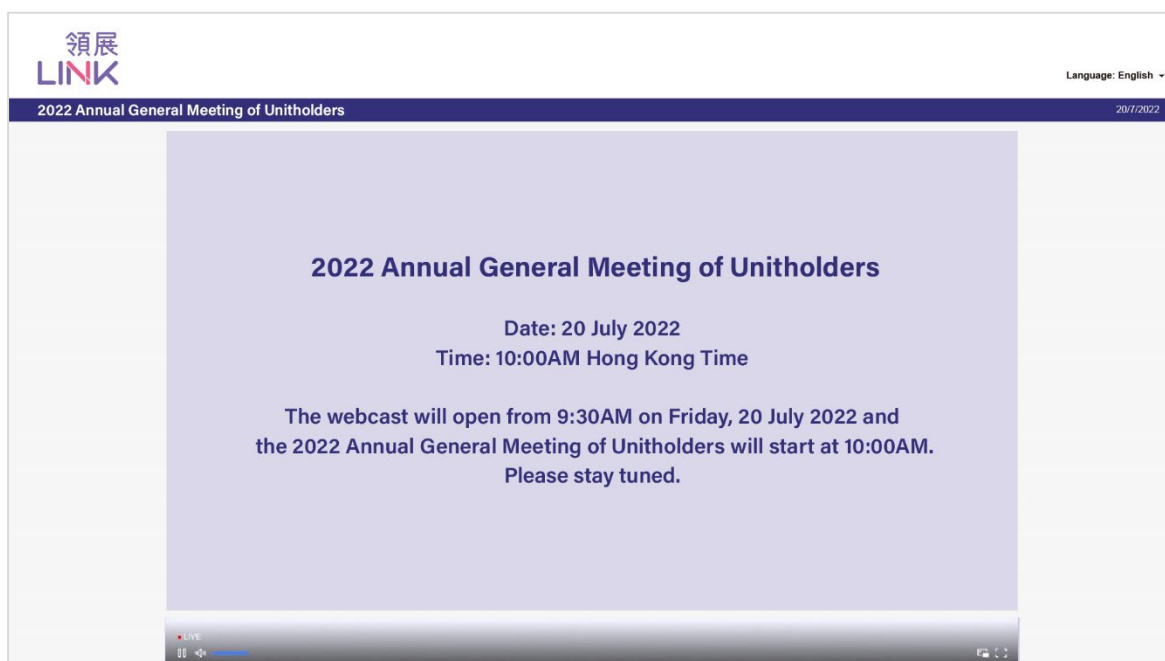




6. Once webcast is “Live”, the welcome image will automatically be replaced by live stream of actual event.
