# **Personal Information Collection Statement**

This Statement is made by Link Asset Management Limited ("Link Asset Management") as manager of Link Real Estate Investment Trust ("Link REIT"), Link Properties Limited, Great Land (HK) Limited, Link Monte (HK) Limited and Lucky Spring Developments (HK) Limited (collectively "Link", "we", "our" or "us"), in accordance with the Personal Data (Privacy) Ordinance (Cap. 486) of the Laws of Hong Kong Special Administrative Region ('the PDPO'). This Statement intends to notify you why your personal data is collected, how it will be used, to whom the personal data will be transferred and to whom data access requests are to be addressed.

### Types of Personal Data Held

We hold four broad categories of personal data, namely customers' and tenants' personal data, business associates' personal data, employment-related personal data and website users' personal data.

### **Collection - Why We Collect Your Data**

From time to time, we may collect your personal data to provide our services to you and in an effort to improve your customer experience. You are not obliged to provide your personal data to us but if you do not, we may not be able to provide you with some of the information, materials, services and/or products of Link REIT, Link Properties Limited, Great Land (HK) Limited, Link Monte (HK) Limited and Lucky Spring Developments (HK) Limited.

We will indicate in the relevant forms or applications if the required personal data is for obligatory or voluntary purposes. If personal data is to be used for an obligatory purpose, you MUST provide your personal data to us if you want us to provide the service for which you are applying. If personal data is only to be used for a voluntary purpose, you can tell us not to use your personal data for that purpose and we will refrain from doing so.

If you are under the age of 18, you must ask your parent or guardian before providing any personal data to us.

### Use - How Your Data May Be Used

Personal data held by us will be used:

- 3. any agent, contractor or third party service provider who provides administrative, telecommunications, computer, payment, content, information or other marketing and promotional services to us in connection with the operation of our business and activities at or in relation to Link Premises;
